# 一、僑外生就學期間工讀

## Foreign Students Working While Studying in Taiwan

### 1. 適用對象：Applicable to

來臺**正式入學修習**科、系、所課程之僑生、港澳生及外國留學生，**入學後即可申請**，惟來臺**學習語言課程**之外國留學生，則**須修業6個月以上**，方可提出申請。

Foreign and overseas compatriot students or those from Macau and Hong Kong can apply to work after officially enrolling on courses at a college, university or graduate school in Taiwan. However, foreign students who study languages in Taiwan can only file an application after studying for a minimum of six months.

### 2. 申請方式：How to apply

僑外生申請工作許可，應**採線上申辦**，經由「**外國專業人員工作許可申辦網**」(<https://ezwp.wda.gov.tw>) **提出申請**

Foreign and Overseas Compatriot students can apply for a work permit online through the “Work permit for foreign professional worker portal” at (<https://ezwp.wda.gov.tw>)

### 3. 許可期間、工讀時數：

#### Permitted work time with a valid work permit

工作許可有效期間**最長為1年**，**工作時間每星期以20小時**為限(寒暑假除外)

Work permits are valid for a maximum of one year. Applicants can work up to **20 hours per week**, with additional working hours allowed during summer and winter vacations.

## 二、現行僑外生留臺就業途徑

### Various Ways for Foreign Students to work in Taiwan

#### 1. 專門性及技術性工作 (Specialized or technical work)

##### (1) 依一般薪資、工作經驗條件申請

Apply by Wages and Work Experience (ordinary way)

- 外國人應符合下列資格之一：(1)取得證書或執業資格 (2)大學畢業後需具2年以上工作經驗，或碩士以上 (3)服務跨國企業滿1年以上經指派來臺工作 (4)未具學歷而有5年以上工作經驗，並有創見或特殊表現者；**且月薪須達新台幣4萬7,971元。**
- 在台修讀大專院校畢業之僑外生，不受工作經驗限制，但須符合薪資門檻。
- Foreigners employed for specialized or technical works should meet the requirements of wage, education, and working qualifications. And the salary shall be **no less than NTD \$47,971.**
- For foreign students graduating from universities in Taiwan, work experience requirements may be waived, but salary threshold criteria must still be met.

##### (2) 僑外生留臺工作評點制

Apply by Points System (Scoring Criteria) for Foreign / Overseas Compatriot Students to Work in Taiwan

- 在臺取得副學士(含)以上學位，並經審核**累計點數滿70點(滿分200點)**，即符合資格。審核項目共有八項，包括：(1)學歷 (2)聘僱薪資 (3)工作與實習經驗 (4)職務資格 (5)華語文能力 (6)他國語言能力或成長經驗 (7)政府政策 (8)獎學金或成績優異者
- The employer and foreign / overseas compatriot student will be assessed based on eight criteria, including education, salary, work experience and internship, language proficiency, background, etc. The MOL will distribute employment permits to those who **score above 70 (out of 200) points.**

#### 2. 留用外國中階技術人力計畫(Retention of Foreign Intermediate Skilled Workforce Program)

##### ● 適用對象：Applicable to:

①在臺連續工作達6年以上、具一定技術(資深)移工  
Migrant workers who have worked continuously in Taiwan for 6 years or more and possess certain skills (senior migrant workers).

##### ②在台畢業之副學士學位以上僑外生

Overseas compatriot students and foreign students who have graduated in Taiwan with an associate degree or higher.

#### 2. 留用外國中階技術人力計畫(Retention of Foreign Intermediate Skilled Workforce Program)

##### ● 資格：Qualifications:

①雇主資格：與聘僱移工條件相同，符合資格者由雇主申請聘僱，每次許可期間為3年。

Employer qualifications: Same as the conditions for employing migrant workers. For those who meet the qualifications, the employer applies for employment. Each permission period is 3 years.

②外國人資格：達一定薪資門檻及技術資格條件

Foreign individual qualifications: Must meet certain salary threshold and technical requirements.

### 3. 旅宿服務工作(Hotel-related work)

- 1. 雇主應為政府單位登記並經許可之觀光旅館、旅館業或民宿，並由雇主提出申請聘僱在台畢業之副學士以上僑外生**  
Employers who operate a tourist hotel, hotel or B&B registered with the government can, with the permission of the authorities, apply to hire foreign and overseas compatriot students who graduated from a school in Taiwan with an associate degree or higher
- 2. 畢業僑外生需經80小時以上訓練課程**  
Foreign and overseas compatriot students are required to complete at least 80 hours of relevant training.
- 3. 受聘僱從事訂房、接待、房務、清潔及旅宿業經營所屬餐廳外場**  
Foreign and overseas compatriot students can be employed to engage in room booking, receiving guests, housekeeping, cleaning and non-kitchen related work in a hotel restaurant
- 4. 初次受聘薪資應達每月30,000元以上**  
For first-time employment, the minimum monthly salary for foreign and overseas compatriot students is NT\$30,000.

##### ◆ 評點制重要時程 Timeline for the Implementation of the Points System

###### ● 2014年7月-勞動部建立「僑外生留臺工作評點新制」

July , 2014 - The "Points System (Scoring Criteria) for Foreign and overseas compatriot Students to Work in Taiwan" firstly introduced.

###### ● 2022年4月-評點制申請全面數位化，修正評點制並開放特定副學士學位申請

April, 2022 - Comprehensive digitalization of point system applications. In addition, the "Points System (Scoring Criteria)" was revised, allowing specific foreign students with an associate's degree to apply for work permits through the point system."

###### ● 2024年6月-新增社工師工作，擴大製造業、金融服務業工作內容。修正評點制評分表，增列採計實習經驗、調整在校期間領取政府獎學金之配點及總點

June, 2024- Add social worker occupations, expand job content in the manufacturing and financial services industries, and revise the point system to include internship experience. Adjust the points allocation for receiving government scholarships during the study period, and revise the total points.

##### ◆ 評點制重要時程 Timeline for the Implementation of the Points System

- **2024年8月**-取消僑外生評點制公告之人數數額。並新增雇主資格規定：經中央主管機關會商中央目的事業主管機關專案認定後，得不受社團法人社員人數、財團法人設立基金及業務支出金額規定之限制。

August, 2024-Remove quota for points system for foreign students and introduce new employer eligibility: After the joint consultation of the central authorities, certain organizations may be exempt from restrictions on member numbers (associations) or funds and operational expenses (foundations).

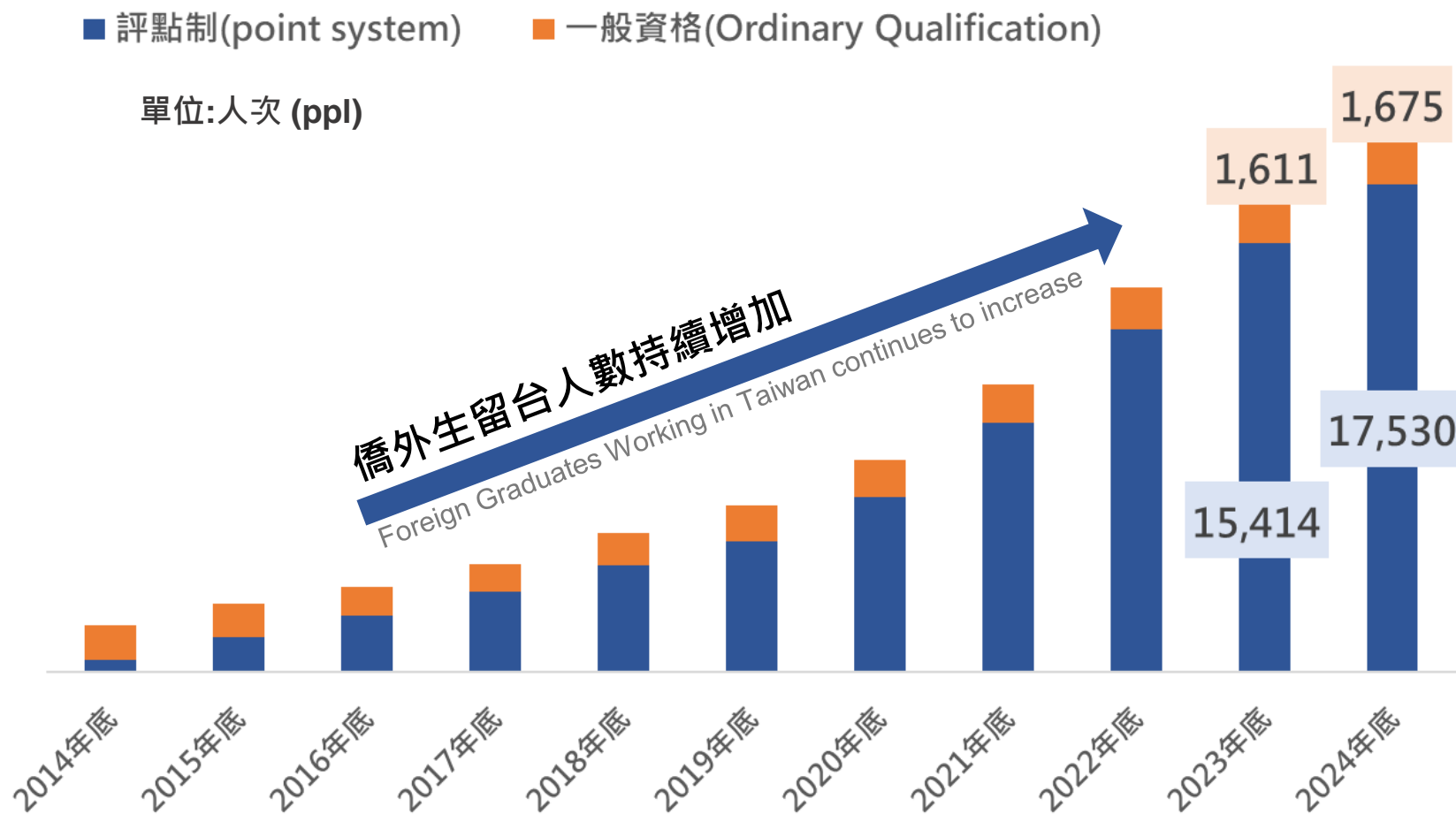
- **2025年1月**-公告指定調酒工作，為就業服務法第46條第1項第1款所稱專門性或技術性工作。

(January, 2025- “bartending” has been designated as a specialized or technical occupation as defined in Article 46, Paragraph 1, Subparagraph 1 of the Employment Service Act.

#### ◆ 近年留臺工作僑外生人數 Foreign Graduates Working in Taiwan



2024年12月：

- 留臺工作僑外生達19,205人次
- 評點制達17,530人次，佔整體 91%
- Until the end of 2024, there have been 19,205 ppl approved to work in Taiwan (17,530 ppl through Points System, which is about 91% of the total).

##### Foundational Rules Relating to Foreigners Working in Taiwan

- Article 43, Employment Service Act

A foreigner may engage in work within the Republic of China only when his/her employer has obtained a work permit via application.

◎ 每次申請聘僱許可期間最長為3年，屆滿前可再申請展延，且無展延次數限制

Work permit shall have a maximum effective term of 3 years, and when necessary, the employer may apply for a further extension up to 3 years at a time.
