1. Submit an application for department transfer during the <u>second semester of each academic year</u> within the deadline announced by the Office of International Affairs

- 2. The review standards for department transfer shall be independently set by each department.
- 3. Bachelor program overseas students under any one of the following conditions shall not apply for transfer:
  - (1) Overseas students who have studied at NCYU for less than one academic year (including the current semester of application).
  - (2) Overseas students in their senior year of study or above (the fifth year or above for the Department of Veterinary Medicine students).
  - (3) Overseas students who are still on a leave of absence from school.
  - (4) Students in full-time programs and extension education programs shall not be allowed to apply for department or class transfer across programs.
  - (5) Students who are under the restrictions of the regulations of various admission methods. Special circumstances shall be handled in accordance with the admissions regulations pertaining to various admission methods.
- 4. Students who have been approved for department transfer shall not be allowed further application for transfer or return to their original department.
- 5. Other relevant regulations shall be handled in accordance with the provisions of the National Chiayi University Student Department Transfer Regulations.
