壹、申請資格

I. Eligibility

- 一、具外國國籍且未曾具有中華民國國籍,於申請時不具僑生資格者。
- A. A person of foreign nationality who has never held Republic of China ("ROC") nationality and who does not have overseas Chinese student status at the time of his/her application.
- 二、具外國國籍並符合下列規定,且最近連續居留海外6年以上者(計算至2024年09月01日) :
- B. A person of foreign nationality who meets the following requirements and who in the immediate past has resided overseas continuously for at least six years (up to September 1, 2024):
 - (一)申請時兼具中華民國國籍者,應自始未曾在臺設有戶籍。
 - 1.A person who at the time of his/her application also holds dual R.O.C. nationality shall have never had household registration in Taiwan.
 - (二)申請前曾兼具中華民國國籍,於申請時已不具中華民國國籍者,應自內政部許可喪失中華民國國籍之日起至申請時(計算至2024年09月01日)已滿8年。
 - 2. A person who before the time of his/her application also held dual R.O.C. nationality butno longer does at the time of his/her application shall have renounced his/her R.O.C. nationality with the approval of the Ministry of the Interior on a date at least eight full years (up to September 1, 2024) before making his/her application.
 - (三)前二款均未曾以僑生身分在臺就學,且未於當學年度經海外聯合招生委員會分發。
- 3. The persons referred to in the preceding two subparagraphs must have never previously undertaken studies in Taiwan as an overseas Chinese student nor have accepted a placement by the University Entrance Committee for Overseas Chinese Students in the current academic year. 依教育合作協議,由外國政府、機構或學校遴薦來臺就學之外國國民,其自始未曾在臺設有户籍者,經主管教育行政機關核准,得不受前二項規定之限制。

A foreign national who was selected by a foreign government, organization, or school to study in Taiwan in accordance with the Education Cooperation Framework Agreement, and who has never had household registration in Taiwan may be given exemption from the restrictions set out in the preceding two paragraphs if the competent education administrative authority gives approval. 具外國國籍並兼具中華民國國籍,且於教育部外國學生來臺就學辦法中華民國100年2月1日修正施行前已提出申請喪失中華民國國籍者,得依原規定申請入學,不受第二項規定之限制。 A person who held both foreign and R.O.C. nationalities and applied for annulment of his/her

R.O.C nationality before the date of effect of the February 1, 2011 amendment to the Regulations Regarding International Students Undertaking Studies in Taiwan may apply for admission as an international student in accordance with the provisions in place before the amendment and is not subject to the restrictions set out in Paragraph B.

The aforementioned ROC nationality is defined in accordance with Article 2 of the Nationality Act

有下列各款情形之一者,屬中華民國國籍:

A person shall have the national of the ROC under any of the conditions provided by the following Subparagraphs:

- 一、出生時父或母為中華民國國民。
- i. His/her father or mother was a national of the ROC when he/she was born.
 - 二、出生於父或母死亡後,其父或母死亡時為中華民國國民。
- ii. He/she was born after the death of his/her father or mother, and his/her father or motherwas a national of the ROC at the time of death.
 - 三、出生於中華民國領域內,父母均無可考,或均無國籍。
- iii. He/she was born in the territory of the ROC, and his/her parents can't be ascertained or both were stateless persons.

四、歸化者。

iv. He/she has undergone the naturalization process.

前項第一款及第二款之規定,於本法中華民國八十九年二月九日修正施行時未滿二十歲之人,亦適用之。

Preceding Subparagraph 1 and Subparagraph 2 shall also apply to the persons who were under twenty years old when the Nationality Act was amended and promulgated on Feb 9, 2000.

- 三、具外國國籍,兼具香港或澳門永久居留資格,且未曾在臺設有戶籍,申請時於香港、澳門或海外連續居留滿6年以上者。
- C. An applicant of foreign nationality, who is eligible for permanent residence in Hong Kong or Macao, who has never had household registration in Taiwan, and who at the time of his/her application has resided in Hong Kong, Macao, or elsewhere overseas continuously for at least six years.
- 四、曾為大陸地區人民具外國國籍且未曾在臺設有戶籍,申請時已連續居留海外6年以上者
- D. An applicant who was formerly from the Mainland Area has foreign nationality and has never had household registration in Taiwan, and who at the time of his/her application has resided overseas continuously for at least six years.

第二、三、四項所稱海外,指大陸地區、香港及澳門以外之國家或地區;所稱連續居留,指外國學生每曆年在國內停留期間不超過120日。連續居留海外採計期間之起迄年度非屬完整曆年者,以各該年度之採計期間內在國內停留期間未逾120日予以認定。

The term "overseas" used in Paragraph B, C, D refers to countries or regions other than the Mainland Area, Hong Kong, and Macau; the term "reside overseas continuously" means that an international student has stayed in Taiwan for no more than a total of 120 days in each calendar year. When calculating the number of consecutive years spent overseas, if the initial or final year of the period is not a complete calendar year, any time spent in Taiwan in the initial or final year must not exceed 120 days.

The only exceptions to this method of calculation are for those who fulfill one of the following requirements with supporting documents. It is not counted when calculating how long they were in Taiwan in a particular year if the person has documentary proof that they:

- (一)就讀僑務主管機關舉辦之海外青年技術訓練班或教育部認定之技術訓練專班。
- 1. Attended an overseas youth training course organized by the Overseas Compatriot Affairs Council or a technical professional training program accredited by the Ministry of Education;
- (二)就讀教育部核准得招收外國學生之各大專校院華語文中心,合計未滿2年。
- 2. Spent a total period of less than two years undertaking Chinese language classes at a Chinese language center at a university or tertiary college which has Ministry of Education approval to recruit students overseas;
- (三)交換學生,其交換期間合計未滿2年。
- 3. Spent a total period of less than two years in Taiwan as an exchange student;
- (四)經中央目的事業主管機關許可來臺實習,實習期間合計未滿2年。
- 4. Spent a total period of less than two years undertaking an internship that they came to Taiwan to undertake with the approval of the designated central competent authority.
- 五、外國學生須符合教育部採認之高中、大學或獨立學院畢業者(請參考教育部國際及兩岸教育司網頁: https://depart.moe.edu.tw/ed2500/)。外國學生具國外高中畢業資格者,得申請入學本校學士班;具學士學位者或具有與我國學制相當之同等學力資格者,得申請入學本校碩士班;具碩士學位者或具有與我國學制相當之同等學力資格者,得申請入學本校博士班
- E. International students must have graduated from the high schools, colleges or universities recognized by the Ministry of Education (for more information, please visit: https://depart.moe.edu.tw/ed2500/). International students with a foreign high school diploma may apply for the undergraduate programs at National Chiayi University (hereinafter referred to as "the University"); those with a bachelor's degree or an equivalent academic qualification may apply for the University's Master's programs; those with a Master's degree or an equivalent academic qualification may apply for the University's doctoral programs.

Start from academic year 2014, the graduates from the schools in Hong Kong, Macau or other countries where the graduation grade is equivalent to the second grade of Taiwan's high schools may apply for the University's undergraduate programs, taking 12 additional credits is required within the study period in accordance with the University's requirement to complete their study.

Undergraduate program of the second application period is form April 15, 2024 to May 15, 2024 (Taiwan time; GMT+8)

The admission will be cancelled if such documents cannot be submitted on time.

- 一、國立嘉義大學(以下簡稱本校)為招收優秀外國籍研究生(以下簡稱外國研究生至本校就讀,提升本校國際化,特依據教育部「外國學生來臺就學辦法」第十五條之規定,訂定「國立嘉義大學外國研究生獎學金發放要點(以下簡稱本要點)
- 二、國立嘉義大學外國研究生獎學金(以下簡稱本獎學金)之經費來源包含教育部補助款、外界捐款、及由本校學雜費提撥之就學補助金支應。

三、獎學金頒發對象:

- (一)符合教育部「外國學生來臺就學辦法」申請至本校修讀碩、博士學位之外國研究生。
- (二)具本校正式學籍且於入學時領有本獎學金之外國研究生。

四、獎學金種類如下:

(三) 學雜費<u>基數</u>及學分費補助<u>(不包括代收代辦費、論文指導費、保險、住宿及網路使用費</u> 等相關費用)。

若非指導教授特別要求,學分費依各系所課程結構為補助原則。

- (十六) 除寒暑假外,未到校上課或未經學校許可離開我國境內之時間超過二個月,註銷其受 獎資格。
- 九、本要點未盡事宜悉依相關法規辦理。
- 十、本要點經行政會議通過,陳請校長核定後實施。

Appendix III Guidelines for International Student Scholarships of National Chiayi University

amended by the Administration Council on August 10, 2021 amended by the Administration Council on April 12, 2022

Article1

National Chiayi University (hereafter NCYU or the University) encourages outstanding international postgraduate students enrolled at the University to promote internationalization. In accordance with the "Regulations Regarding International Students Undertaking Studies in Taiwan" Article 15, the University promulgates "Guidelines for International Student Scholarships of National Chiayi University" (hereafter the Guidelines).

Article2

The financial sources of International Student Scholarships at National Chiayi University (hereafter the Scholarships) include subsidies from the Ministry of Education, donations, and the University funds.

Article3

Scholarship recipients:

- 1. Those who meet the requirements according to the application of Regulations Regarding International Students Undertaking Studies in Taiwan of MOE, the international postgraduate students can apply for the scholarships before the students have the qualifications for admission.
- 2. The international postgraduate students who have the University's official student status and had received this scholarship upon admission.

Article4

Scholarships are divided into:

- 1. Tuition and credit fee subsidies (the administration fees, thesis supervision fees, insurance premiums, accommodation, or internet access are not included).
 - The credit fee subsidy shall be in principle based on the course structure of each department, unless specifically requested by the advisor.
- 2. Monthly scholarship: For graduate students, the monthly scholarship shall be NT\$8000; for doctoral students, the monthly scholarship shall be NT10,000, from August each year to July in the following year (for those who are enrolled in the second semester: from February each year to January in the following year.) For new students, the scholarship shall only be paid from the month of registration, which month must have 15 days or more to be within the semester; for graduating students, the scholarship shall only be paid until the month of graduation, which month must have 15 days or more to be within the semester.

Article5

Qualifications for applying the scholarship:

- 1. The new international postgraduate students may submit an application for the Scholarships to the Office of International Affairs while they are filling out the application form for admission. The application for the Scholarships shall be reviewed and decided by the International Student Admission Review Committee, after being initially reviewed by the respective department or program for recommendation, and after being prioritized for scholarship type and approval order. Qualifications for applying are as follow:
 - (1) Proof of beginner level (TOCFL Level 2/ CEFR A2) or above of Chinese proficiency, or the proof of CEF B1 or above of English proficiency.
 - (2) With the status of "accepting an employment offer" on the resident certificate or the status of "employment" on the visa, the items of the

- Scholarships to be provided shall cover at most the tuition fee per semester and the credit fee.
- (3) Anyone who has received the scholarships provided by various government agencies of our country may not receive the Scholarships. Violators, after being found to have repeated in receiving the scholarship, may be revoked of the qualification for the Scholarships.
- 2. For continuing Scholarships for international graduate students, in and after the second year of study, the awardees must apply again, and submit the previous semester's transcript to the Office of International Affairs before July 20th (awardees enrolling in fall semester) or before February 5th (awardees enrolling in spring semester). The Office of International Affairs will be responsible for countersigning with relevant units, and by the College, with the approval of the President of the University. Qualifications for applying are as follow:
 - (1) Graduate students should complete the minimum amount of 8 credits in course taking in each semester of the previous school year with a grade of 80. Doctoral students should complete the minimum amount of 4 credits in course taking in each semester of the previous school year with a grade of 80. Senior graduate students without course load can submit research papers for review. The credits mentioned above should be the credits required by each department.
 - (2) Acquires a conduct evaluation result of 80 above.
 - (3) Submit the transcript of each term's mandarin studies offered by the Language Center in the previous academic year with a grade of 70 percent or above, or pass TOCEL and submit the course exemption certificate approved by the Language Center.
- (4) Recommendation letter from the adviser or the dean of department. Students who suspend because of pregnancy could apply for the Scholarship with transcripts of academic years after reinstatement.

Article6

Description of scholarship award:

The Scholarships granted to international students are dependent on the financial conditions of the University. In principle, the budget for scholarships will be evenly allocated among the colleges.

- 1. The new international postgraduate students:
 - (1) Type A Scholarships: waiver of tuition, and credit fees, as well as a monthly scholarship.
 - (2) Type B Scholarships: a waiver of tuition and credit fees.
 - (3) Prioritization for master's program Type A Scholarships is as follows:
 - i. First priority recommendation: For the international degree program, each program may present special recommendations on up to three candidates.
 - ii. Second priority recommendation: Maximum of two candidates for each college excluding international degree programs.
- 2. Renewal for the international postgraduate students:
 - (1) The Scholarships are awarded on a year-by-year basis and annual applications are necessary.
 - (2) The maximum term for master's students 2 years, and for doctoral students 4 years.
 - (3) The international postgraduate students' scholarship will be transferred directly to a personal post office account after the 15th of every month (It will be implemented for incoming freshmen from the academic year 112). The Scholarship for August awarded to the second-year graduate students will be issued after the 15th of September. For new awardees

enrolling in fall and spring semesters, those students will receive the September scholarships after the 15th of October, while February scholarships in the 15th of March respectively.

Article7 Obligations of awardees:

The awardees of NCYU scholarship and Taiwan Scholarship should participate in international students' activities in NCYU.

Article8 The scholarship will be terminated in the case of:

- 1. Failure to uphold the standard of the minimum credit hours or GPA, which are specified in Subparagraph 2 of Article 5, above.
- 2. Recipient's suspension, withdrawal, or graduation.
- 3. Violating the Item 3, Subparagraph 2 of Article 5, above.
- 4. Receiving the request to move out of the dormitory.
- 5. Disqualification for admission of Regulations Regarding International Students Undertaking Studies in Taiwan (under this circumstance the scholarship awarded must be returned in full amount).
- 6. Engaged in any illegal acts in Taiwan or acts endangering the reputation of the University, which is verified to be true.
- 7. Except for the winter and summer vacations, the awardee who has not attended the class in the University or has left our country without the permission from the University, shall be suspended for the payment of the Scholarships for the months that he/she is not present for the schooling.
- 8. Except for the winter and summer vacations, if the awardee has not attended the class in the University or has left our country without the permission from the University exceeds more than two months, his or her qualification as the awardee shall be cancelled.

Article9 Related issues not specified in the Guidelines are subject to the related regulations.

Article 10 The Guidelines shall come into force as passed through the University Administration Council and with approval of the University's President.

The Guidelines are enacted in Chinese, which shall prevail in case of any discrepancy between the English translation and the Chinese original.

- 二、本校大學部外國學生獎學金(以下簡稱本獎學金)之經費來源,包含教育部補助款、外界捐款及本校學雜費收入。

三、獎助對象、標準及金額:

- (一)透過本校外國學生申請入學管道入學新生,並具有正式學籍之外國學生:
 - 1.第一學年學雜費減免至本地生收費標準(含保留學籍者)。
 - 2.休學、退學、開除學籍者,當學期已減免之費用,不予追繳。復學或再行入學時,休學、退學前所就讀之當學期、曾減免之費用,不得重複減免。
- (二)已經就讀本校一學年以上,具有正式學籍之大學部外國學生,本獎助學金每次核定一學<u>年</u>, 須逐次申請。申請資格規定如下:
 - 1.<u>A 類獎學金:</u>前一<u>學年各別</u>學期<u>應</u>至少修習九學分,班級排名<u>各別學期</u>前百分之五十 (排名百分比計算至小數點後 1 位,採四捨五入計算),操行成績八十分以上,每人 當學年度各別學期學雜費減免至本地生收費標準。
 - 2.**B 類獎學金:前一學年各別學期應至少修習九學分,**班級排名**各別學期**前百分之五十一至百分之七十(排名百分比計算至小數點後 1 位,採四捨五入計算),操行成績八十分以上,每人當學年度各別學期學費減免至本地生收費標準。
 - 3.休學、退學、開除學籍者,當學期已<u>減免</u>之費用,不予追繳。復學時<u>或再行入學時,休</u> 學、退學前所就讀之當學期,曾減免之學雜費,不得重複減免。
- (三)外國學生如有以下情況者,不得申請:
 - 1.獲政府所提供之其他獎補助學金者。
 - 2.延長修業年限之學生。

四、申請本獎學金流程

- (一)申請就讀本校之外國入學新生應於申請入學時向國際事務處提出申請本獎學金,併同本校 招收外國學生入學審查複審會議進行審查。
- (二)已經就讀本校一學年以上,具有正式學籍之外國學生應於<u>每年七月二十日前</u>檢附申請表及 前一學年成績單(含每學期班級排名),向國際事務處提出申請。

學生修業期間因懷孕休學者,復學後得檢附申請表及歷年成績單提出申請。

五、大學部外國學生就學第二年以後本獎學金之審查,由國際事務處負責簽會相關單位及學院確 認,並陳請校長核定。

六、獎學金之停發及取消

- <u>(一)</u>獲獎學生完成註冊後,除寒暑假外,於受獎期間內離校超過一個月以上,經查證屬實<u>,並不得</u> 於爾後在學期間,再度申請本獎學金。
- <u>(二)</u>獲獎學生於受獎期間在校內外有全職工作或持有工作居留證,經查證屬實,<u>並不得於爾後在</u> 學期間,再度申請本獎學金。
- 七、本獎學金受獎生不得兼領校<u>內</u>外<u>任何</u>獎助學金。受獎生如有重複領取獎助學金之情形,經查證屬實,除註銷本獎學金受獎資格外,並不得於爾後在學期間,再度申請本獎學金。
- 八、本要點如有未盡事宜,依本校相關規定辦理。
- 九、本要點經行政會議通過,陳請校長核定後實施。

Appendix IV <u>Implementation</u> Guidelines for National Chiayi University International Undergraduate Students Scholarship

Approved on August 10, 2021 by the 7th Administrative Meeting

Article 1

The National Chiayi University (thereinafter referred to as "the University") has stipulated the "<u>Implementation</u> Guidelines for National Chiayi University International Undergraduate Students Scholarship" (thereinafter referred to as "the Guidelines") in accordance with the "Regulations Regarding International Students Undertaking Studies in Taiwan" of the Ministry of Education, to promote internationalization, attract talented international undergraduate students to come to the university, and encourage their learning.

Article 2

The university's scholarship for international undergraduate students (thereinafter referred to as "the Scholarship") will be funded through subsidies from the Ministry of Education, outside donations, and University's tuition and fees income.

Article 3

Recipients, Standards, and Amounts of the Scholarship:

- 1. New international students who have applied for admission and enrolled to the university.
 - (1) The tuition and fees of the first school year will be reduced to the same standard as
 - (2) that for local students (including those who have retained their enrolment).
 - (3) Students who have taken a leave of absence, dropped out, or been withdrawn from the university will not be requested to return the reduced amount of the tuition and fees. For those who have reentered or readmitted the university, their tuition reduction shall not be taken again if it has been taken in the semesters before their leave of absence or dropping out.
- 2. For students who have been studying in the university for more than a year with formal enrolment, the scholarship funds will be released on **an academic year** basis and shall be applied each **academic year**. The qualifications for application are as follows:
 - (1) <u>Category A scholarships:</u> Students who took at least 9 academic credits <u>both</u> <u>semesters of the previous academic year</u>; rank within the top 50% of the class (The percentage of class ranking is rounding off to the 1st decimal place) <u>both</u> <u>semesters of the previous academic year</u>; and with a conduct score of 80 or above, will <u>have their tuition and miscellaneous fees reduced to the local fee rate for the academic year in question</u>.
 - (2) <u>Category B scholarships:</u> Students who took at least 9 academic credits <u>both</u> <u>semesters of the previous academic year</u>, rank from the top 51% to top 70% of the class <u>both semesters of the previous academic year</u>, with a conduct score of 80 or above (The percentage of class ranking is rounding off to the 1st decimal place), will <u>have their tuition fees reduced to the local fee rate for the academic</u>

vear in question.

(3) Students who have taken a leave of absence, dropped out, or been withdrawn from the university will not be required to repay the amount **already reduced** during the semester

However, they will not be awarded <u>any reduced tuition or miscellaneous fees</u> taken <u>for the semester prior to taking a leave of absence or dropping out</u>, after resuming their studies <u>or being readmitted to</u> the university.

- 3. Students under these situations may not apply:
 - (1) Those who have not paid tuition and registration fees in the university
 - (2) Those who receive other scholarships from the government

Article 4

- 1. Procedure for Scholarship Application
 - (1) New international students applying to the university shall submit an application for scholarship to the Office of International Affairs together with their college application.
 - Both applications will be sent to the Admissions Review Committee of the university for
 - review.
 - (2) Students who have been studying in the university for more than a year with formal enrolment shall apply to the Office of International Affairs **prior to July 20th of the year in question**, and submit the application form (including the letter of consent for scholarship) and last semester's transcript (including class ranking). Students who took a leave of absence due to pregnancy shall attach their application forms together with their transcripts to apply after resuming their studies in the university.

Article 5

The review of the scholarship of the international student's scholarship after the second year of schooling shall be confirmed and signed by International Affairs, the relevant units and colleges. The list of awardees will be forwarded to the University's President for approval.

Article 6

Revocation of Scholarship

- 1. After enrolment, except for winter and summer breaks, awarded students who leave school for more than a month <u>may not thereafter reapply for the scholarship during</u> their period of studies at the University.
- 2. The awarded students who are found to have a full-time job on or off campus, or hold a working permit **may not thereafter reapply for the scholarship during their period of studies at the University**.

Article 7

Students who receive this scholarship, at the same time, may not accept <u>anv</u> other scholarships in full amount or scholarship amounts which are greater than this one, <u>either</u> from outside <u>or inside</u> the university. Those who have received scholarship other than this

one will be requested to pay back the amount already received, their scholarship will be revoked as well upon verification, and the student may not thereafter reapply for the scholarship during their period of studies at the University.

Article 8

Any matter not covered by these Guidelines shall be handled in accordance with the university's relevant rules and regulations.

Article 9

The Guidelines have been approved by the Administrative Meetings and shall be implemented after approval by the University's President.
